**Pipeline Loss Allowance:** An assessment of two tenths of one percent (0.2%) on net quantities so determined for acceptance by Carrier will be deducted to cover losses inherent in the transportation of Crude Petroleum. Loss allowance will be collected as Crude Petroleum enters Permian Express Partners LLC’s pipeline at Longview, Texas. This loss allowance supersedes Rule 75(f) of the F.E.R.C. I.C.A. Oil Tariff No. [W] ~~8.1.0~~ 8.3.0 (Permian Express Partners LLC) and any successor provision thereto.

**Specifications and Quality:** Where there are inconsistencies related to product specifications or quality between F.E.R.C. No. [W] ~~8.1.0~~ 8.3.0 (Permian Express Partners LLC) and F.E.R.C. No. 71.7.1 (Plains Pipeline, L.P.), supplements thereto and successive issues thereof, then the more stringent standards between the two tariffs shall apply.
