**GATHERING RATE:** When service is performed by Carrier, a charge of [I] **sixty-eight and seven tenths cents (68.7¢)** per barrel will be made in addition to the trunk rate, except for the following locations:

**UNLOADING CHARGES:** All shipments unloaded from tank trucks into Carrier's trunk line facilities will be subject to a charge of [I] **ten and eight tenths cents (10.8¢)** per barrel. All shipments unloaded from tank trucks into Carrier's gathering facilities will be subject to the applicable gathering charge for said gathering facility. Such charges will be in addition to trunk

transportation rates published in applicable tariffs.

**LOADING CHARGES:** All shipments loaded from Carrier's trunk line facilities into tank trucks will be subject to a charge of **[I] ten and eight tenths cents (10.8¢)** per barrel. Such charges will be in addition to trunk transportation rates published in applicable tariffs.

**DEDUCTIONS:** See Item No. 40 of Rules and Regulations.

**NOTE:** The following applies only to referenced origins and destinations as indicated on schedule:

*(1) The Sweet Crude Oil Sulfur content for receipts at these origin points and deliveries at this destination point can not be greater than twenty-eight hundredths of one percent (0.28%) by weight.*
