- (1) **RATE A (Anchor Rate Phase I):** The joint tariff anchor rate is available to any Shipper for the transportation of Crude Petroleum produced from acreage that is dedicated on Phase I, prior to August 1, 2012, to shipment on the pipeline pursuant to a fully executed Dedication Agreement with ETP Crude LLC.
- (2) **RATE B (Dedicated Rate):** The joint tariff dedication rate and the Dedicated Rate are available to any Shipper for the transportation of Crude Petroleum produced from acreage that is dedicated, subsequent to August 1, 2012, for Phase I, and subsequent to August 30, 2013, for Phase II, to shipment on the pipeline pursuant to a fully executed Dedication Agreement with ETP Crude LLC, with a minimum of 10,000 dedicated acres for a minimum of five years.
- (3) **RATE C (Anchor Rate Phase II):** The joint tariff anchor rate is available to any Shipper for the transportation of Crude Petroleum produced from acreage that is dedicated for Phase II, between August 1, 2013 and August 30, 2013, to shipment on the pipeline pursuant to a fully executed Dedication Agreement with ETP Crude LLC.
- (4) **Midland Station refers to the shared manifold that is located between the Sunoco Midland Terminal owned by Sunoco Partners Marketing & Terminals, L.P. and the adjacent terminal facility owned by Permian Express Terminal LLC.**

Phase I – Includes mainline pipeline facilities initially constructed by ETP Crude LLC, with receipts from Perry Ranch Station to Barstow Station.

Phase II –Includes mainline pipeline expansion facilities constructed by ETP Crude LLC, from Pecos Station to Perry Ranch Station with receipts at Pecos Station.

[N] Notwithstanding Rule 31. D. of ETP Crude LLC Texas R.R.C. Tariff No. 1.6.0 to the contrary, a deduction of two-tenths of one percent (0.2%) (the “PLA”) will be made to cover evaporation, interface losses, and other normal losses during transportation; provided, that any movement from any gathering point to Brooke Station that continues on the same movement to Midland, Texas shall only be charged one PLA with respect to the entire movement from the gathering point to Midland, Texas.

All charges and rates in this tariff are subject to increase each July 1 in accordance with the indexing mechanism set forth in FERC regulation 18 C.F.R. Section 342.3; provided that rate will not be subject to decrease if the indexing mechanism decreases the rate below the initial rate.
