Notwithstanding any provision of a Committed Shipper’s Transportation Services Agreement (“TSA”) to the contrary, the above Uncommitted Rates shall be available to a Committed Shipper for any volumes that such Committed Shipper ships on the Pipeline in excess of such Committed Shipper’s Minimum Volume Commitment (as defined in the TSA).

(4) The following charges apply to both Permian Express 2 (PE2) and Permian Express 3 (PE3):

**Pipeline Loss Allowance:** An assessment of two tenths of one percent (0.2%) on net quantities so determined for acceptance by applicable Carrier will be deducted to cover losses inherent in the transportation of Crude Petroleum.

**WTI Surcharge:** A surcharge of [U] **eight cents (8.00)** per barrel will be assessed on the first seventy-three million (73,000,000) Barrels of WTI Crude Petroleum accepted for shipment at the Origin Point of Midland, Texas.

**Truck Unloading Charge:** When shipments are unloaded from tank truck facilities into the facilities of applicable Carrier at the Origin Point of Midland, a charge of [U] **ten cents (10.00)** per barrel will be assessed in addition to the transportation rates named herein.

**Gathering System Receipt Charge:** For receipts from third party gathering pipelines at Midland into applicable Carrier’s facilities at the Origin Point of Midland, a charge of [U] **ten cents (10.00)** per barrel will be assessed.

**Intrasystem Transfers:** [W] An intrasystem transfer of title to Crude Petroleum will be allowed at Carrier's Midland origin for a fee of 0.75 cents per barrel, with a minimum of \$50.00, charged to the transferor. Recognition of such intrasystem transfers will be subject to both the transferor and transferee following and completing the process established by Carrier for intrasystem transfers. Carrier will allow a Shipper Transfer of one shipper to another, and Title Transfers from one ownership to another for Petroleum in custody of Carrier at the Permian Express Terminal. A charge of one half cent [U] (0.5¢) per barrel with a fifty dollars (\$50.00) minimum will be made to each party directing such transfers.
