- (2) ~~When operating conditions permit, Sunoco Pipeline L.P. will handle, at Ringgold Station, Montague County, Texas, crude petroleum from a connected pipeline of another carrier for delivery to a connected pipeline of another carrier at the rate of eleven and ninety one hundredths cents (11.9¢) per barrel of 42 U.S. gallons.~~**
- (3) ~~When operating conditions permit, Sunoco Pipeline L.P. will handle, at Wortham station, Freestone County, Texas, crude petroleum from a connected pipeline of another carrier for delivery to a connected pipeline of another carrier at the rate of eleven and thirty one hundredths cents (11.3¢) per barrel of 42 U.S. gallons.~~**
