UNLOADING CHARGES: All shipments unloaded from tank trucks into Carrier's trunk line facilities will be subject to a charge of [I] ten cents and eight tenths cents (10.8¢) per barrel. All shipments unloaded from tank trucks into Carrier's gathering facilities will be subject to the applicable gathering charge for said gathering facility. Such charges will be in addition to trunk transportation rates published in applicable tariffs.

RULES AND REGULATIONS: The rates named in this tariff are for the intrastate gathering and transportation of crude petroleum by pipeline, subject to the rules and regulations of the Railroad Commission of Texas, published in Sunoco Pipeline L.P.'s Tariff Texas R.R.C. No. 11, supplements thereto and successive issues thereof, adding that shipments under this tariff are subject to the following crude petroleum quality specifications:

- 1) Must be produced from East Texas fields located in Upshur, Gregg, Rusk, Smith and Cherokee Counties, Texas
- 2) Gravity cannot be less than 20° (twenty degrees) API nor exceed 60° (sixty degrees) API.
