EXCEPTIONS:

Pipeline Loss Allowance: An assessment of two tenths of one percent (0.2%) on net quantities so determined for acceptance by Carrier will be deducted to cover losses inherent in the transportation of Crude Petroleum tendered at the Origin Point of Midland.

Minimum Batch Size: Crude Petroleum will be accepted for transportation under this tariff in shipments not less than sixty thousand (60,000) barrels from one Shipper.

Intrasystem Transfers: An intrasystem transfer of title to Crude Petroleum will be allowed at Carrier's Midland origin for a fee of 0.75 cents per barrel, with a minimum of \$50.00, charged to the transferor. Recognition of such intrasystem transfers will be subject to both the transferor and transferee following and completing the process established by Carrier for intrasystem transfers.
