Effective November 1, 2021 the Lone Star entities are undergoing a rebranding to reflect the Energy Transfer family of names. The entities listed below may impact your company. No contract assignment has occurred, and the terms and conditions of all contracts remain unchanged.

While bank accounts and Federal Employer Identification Numbers will remain the same, please change the company name within your system(s).

In addition to the new company names, carrier codes, shipper codes and location codes relative to the above companies will also change in Transport4 ("T4"). A listing of all changes is attached to this correspondence.

Products will continue to flow as usual, but in order to achieve a clean cutover to our new names, the October end-of-month close along with the start of November business will be performed as follows.

Nominations in T4

- October Nominations in T4: All nominations with requested movement dates prior to 0700, November 1, 2021 should be entered in T4 using the "Lone Star" company names, carriers, shippers and locations.
- October Nominations in T4: All nominations with requested movement dates of November 1, 2021 forward should be entered in T4 using the "Energy Transfer" company names, carriers, shippers and locations.

Meter Tickets in T4

- Physical meter tickets and paper meter tickets will not be booked to shippers' accounts for the month of November until the October close is completed by end of business day, November 5th. This will allow us to close all our systems for October and provide a clean cutover from the old naming conventions to the new naming conventions.

PTOs in T4

- Customers will not be allowed to enter or process a PTO in T4 with a movement date of November 1, 2021 or greater until 0700, November 8th.

Truck Loads in Dearman/T4

- Inventory will be managed within the system to allow customers to continue to load trucks at Mont Belvieu, Hattiesburg and Geismar. A bill of lading will be provided to the truck driver, but the load will not be posted to customer inventory in T4 until the October close is completed by end of business day, November 5th.

Inventory in T4

- Ending inventory held by customers at the various facilities at the close of October business will be renamed to the corresponding Energy Transfer account for November business. Customers will not be able to view November beginning inventory and transactions until October business is completed by end of business day, November 5th.

Y-Grade Customers

- All Y-Grade customers should submit their nominations via email as usual.

Confirmations for Product Sales, Purchases and Exchanges ("Confirms")

- Outgoing confirms for sales, purchases and exchanges with transaction dates of November 1 through November 7, 2021 will not be emailed to customers until November 8th.

General Terms and Conditions for the Sale, Purchase and Exchange of Natural Gas Liquids and Petroleum Products ("GT&Cs")

Beginning November 1, 2021, the Energy Transfer GC NGLs LLC (was Lone Star NGL LLC) GT&Cs will apply to all sales, purchases and exchanges transacted by Energy Transfer GC NGL Marketing LLC (was Lone Star NGL Marketing LLC).
